**WHEREAS**, the existing structure was deemed unfit for human habitation, occupancy and/or use and by the Health Officer and the City’s environmental engineering consultant T&M Associates; and

**WHEREAS**, an Order to Repair or Demolish the structure was issued to the property owner on February 28, 2020, and received and recorded by the Union County Clerk on March 13, 2020; and

**WHEREAS**, as of August 3, 2020 the owner did not comply with the issued and recorded order; and

**WHEREAS**, the City solicited received three (3) quotes for demolition and Caravella Demolition, Inc. (the “Contractor”) submitted the lowest price quote to demolish the existing structure at 916 Broad Street; and

**WHEREAS**, the work included demolition and disposal of the existing structure, and restoration to the disturbed areas.

**NOW, THEREFORE, BE IT RESOLVED**, by the Municipal Council of the City of Rahway, County of Union, State of New Jersey that a contract with Caravella Demolition, Inc. for said work in the amount of twenty four thousand six hundred Dollars (\$24,600.00) is hereby ratified and authorized pursuant to N.J.S.A, 40:11-6(b).

**WHEREAS**, The City Engineer has determined that the City's sanitary sewer collection system is receiving water infiltration and inflow; and

**WHEREAS**, the City of Rahway is unnecessarily conveying stormwater to the Rahway Valley Sewerage Authority Treatment Plant and paying for the treatment of this stormwater; and

**WHEREAS**, it is necessary for the City to investigate, location, and where possible disconnect I&I sources; and

**WHEREAS**, by Resolution No. AR-26-20 T&M Associates. was pre-qualified to provide general engineering services to the City; and

**WHEREAS**, T&M has submitted a proposal dated August 26, 2020 to provide professional engineering services to investigate and assess I&I in the amount of \$134,000; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that resolutions authorizing the award of contracts for "Professional Services" without competitive bids must be publicly advertised.

**NOW, THEREFORE, BE IT RESOLVED**, by the Municipal Council of the City of Rahway, County of Union, State of New Jersey as follows:

1.
