 - b. The City is also undertaking a comprehensive downtown parking study. Mrs. Solomon advised that she will be meeting with the engineers and parking utility officials and will give an update to the redevelopment commissioners at a future meeting.

- 1. Grammercy/R2N2 on East Cherry Street Site work on Monroe Street, which includes curbing, paving, sidewalk and underground utilities have been completed. Installation of striping and signage is pending. Building improvements and pending completion and building sub-code inspections.
- 2. Dornoch II Urban Renewal LLC on Main and Monroe Street building improvements are currently under construction. Site work is expected to commence in the Spring of 2019.
- 4. 1255 Main Street/REVA Building construction is on-going. Curbing and drainage improvements to the surface parking area, perpendicular to the access driveway, has been completed and temporary pavement has been installed.
- 5. Brownstones on Elizabeth Ave foundation and building construction is on-going. Site work is expected to commence in the Spring of 2019.
