**PLEASE TAKE NOTICE** that the regularly scheduled Combined Meeting of the Municipal Council of the City of Rahway, County of Union, State of New Jersey scheduled on November 9, 2020 at 7:00 p.m. was adjourned.

**NOTICE IS HEREBY GIVEN** that in compliance with the provisions of the “Open Public Meetings Act” of the State of New Jersey, N.J.S.A. 10:4 et seq., the City of Rahway, Municipal Council, in the County of Union, in the State of New Jersey, advises that a Meeting will be held on **November 16, 2020 at 7:00 p.m.** by electronic, telephonic communications, videotelephony - teleconference means and/or in the Municipal Court/Council Chambers, 1 City Hall Plaza, Rahway, New Jersey. The City does hereby notify the public that to protect the health, safety and welfare of our citizens while ensuring the continued functioning of government only a limited number of employees may be physically present in the Municipal Court/Council Chambers. City Elected Officials, professionals, and employees may participate virtually.

The agenda items as known at the time of this notice, are to conduct the regular monthly business including, but not limited to Review of Agenda Items, Communications from Mayor, Presentations, Various Communications, Reports, Payment of Bills, Public Comments, Public Hearings, Approval of Minutes, Consent Agenda, Introduction of Ordinances, Adoption of Ordinances, Approval of Resolutions, Miscellaneous (Unfinished) Business, and Council Comment. Formal action will be taken. Please be advised that the Governing Body reserves the right to enter closed executive session per N.J.S.A. 10:4-12. The agenda will be published on the City of Rahway official website ([www.cityofrahway.org](http://www.cityofrahway.org)).

Due to the COVID-19 pandemic, no members of the public shall be permitted to physically attend the meeting. Consequently, the City has taken reasonable precautions to ensure continued access to public meetings, therefore, the public is invited to observe the meeting via a videotelephony - teleconference software platform, a live streaming service and/or other medium so designated. All participants were placed in a holding room before being admitted to the meeting from the meeting host. Upon being granted access to the meeting, participants will be asked to agree to the terms of the meeting as stated by acknowledging this by using the “Yes” button. Any guests failing to do this will be removed from the meeting. All guests will be muted upon being admitted and must ‘raise their hand’ through the platform to be recognized. At the end of the meeting, the host will terminate the connections through the platform.
