COMBINED MEETING OF JANUARY 11, 2021

NOTICE IS HEREBY GIVEN that, in compliance with the provisions of the “Open Public Meetings Act” of the State of New Jersey, N.J.S.A. 10:4 *et seq.*, the City of Rahway Municipal Council, in the County of Union, in the State of New Jersey, advises that a Meeting will be held on **January 11, 2021 at 7:00 p.m.** by electronic, telephonic communications, videotelephony-teleconference means and/or in the Municipal Court/Council Chambers, 1 City Hall Plaza, Rahway, New Jersey. The City hereby notifies the public that to protect the health, safety, and welfare of all, while ensuring the continued functioning of government, only a limited number of people may be physically present at the meeting. Elected Officials, professionals, and employees may participate virtually.

At the time of this notice, the purpose of the meeting is to conduct regular monthly business. The agenda items include but are not limited to: the Review of Agenda Items, Communications from the Mayor, Presentations, Various Communications, Reports, Payment of Bills, Public Comments, Public Hearings, Approval of Minutes, Consent Agenda, Introduction of Ordinances, Adoption of Ordinances, Approval of Resolutions, Miscellaneous (Unfinished) Business, Statement by the Mayor, and Council Comment. Formal action shall be taken. The Governing Body reserves the right to enter closed executive session, per N.J.S.A. 10:4-12. The agenda will be published on the official City of Rahway website (www.cityofrahway.org).

PLEASE BE ADVISED that all meetings of the Municipal Council are open to the public. Due to the COVID-19 pandemic, members of the public may not be permitted to physically attend the meetings. Consequently, the City has taken reasonable steps to ensure continued access to public meetings when gathering restrictions are in place through Executive Order or other enacted regulation. The public is invited to observe the meeting via a videotelephony-teleconference software platform, a live streaming service and/or other medium so designated. Information regarding means to access to the meeting in-person or via broadcast can be obtained from the Office of the City Clerk, will be posted on the City website and/ or the official City social media account(s). Unintended technical difficulties, unforeseen circumstances, or equipment problems (such as hardware failures or software malfunctions) may occur, making it problematic to continue the meeting on a platform. If such an impediment arises, it is recommended that members of the public access the event by means of an alternate medium.

Members of the public are encouraged to **register in advance** for meetings. After the registration is completed, a confirmation email containing information about joining the meeting will be sent. Meetings held using the digital platform will place participants in a holding room, muting microphones before admittance by the host and participants must “raise their hand” through the platform to be recognized. Participants agree to and acknowledge the terms of the meeting by using the “Yes” button. Any guests failing to abide by the terms will be removed. At the conclusion of the meeting, the host will terminate the connections through the platform.
